Motion by Councilman Billman to go in to Executive Session pursuant to Idaho Code 74-206(f) to discuss with legal counsel litigation. Second by Councilwoman Perez. **Motion Passed.** Roll Call vote; Councilwoman Perez, aye, Councilman Billman, aye, Councilwoman Ames, aye, Councilman Bramwell, Aye.
