AN ORDINANCE ANNEXING THE LAND HEREINAFTER DESCRIBED WHICH IS CONTIGUOUS AND WITHIN THE CITY OF DUBOIS, CLARK COUNTY, IDAHO, AND DECLARING THE SAME A PART OF THE CITY OF DUBOIS, CLARK COUNTY, IDAHO, AND REPEALING ALL ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE CITY OF DUBOIS, CLARK COUNTY, IDAHO:

SECTION 1: The land hereinafter described in this Ordinance is contiguous and within the City of Dubois, Clark County, Idaho, and is subject to annexation to the said City of Dubois, Clark County, Idaho, under and pursuant to the provisions of Section 50-222, Idaho Code, as amended, and should be annexed to and become part of the said City of Dubois, Clark County, Idaho.

SECTION 2: The land described in Exhibit A attached hereto and made a part hereof, situate in Clark County, Idaho, shall be and the same is annexed to the City of Dubois, Clark County, Idaho, and shall be, and is hereby declared to be a part of the City of Dubois, Clark County, Idaho.

SECTION 3: The City Clerk is hereby directed to cause this Ordinance to be published in one issue of The Post Register, official city newspaper, within thirty (30) days from the date of the passage and approval hereof, and proof of publication of said Ordinance shall be filed therewith in the office of the City Clerk; and to file a certified copy of said Ordinance with the County Recorder, Auditor, County Treasurer, and County Assessor of Clark County, State of Idaho and with the Idaho State Tax Commission.

SECTION 4: All ordinances, or parts of ordinances, insofar as they are in conflict, shall be, and the same are hereby repealed.

This Ordinance shall be in force and effect from and after its passage, approval and publication.
